

CFSC Competition Subsidy Eligibility Rules

1. The skater must be a FULL member of Carolinas Figure Skating Club.
2. The skater/parent must be active in the club and serve in a volunteer capacity. Numerous volunteer opportunities exist; competitions, test sessions, hospitality, consignment, seminars are just a few of the opportunities. Members are responsible for tracking and reporting their volunteer hours, as well as having the form signed by the person in charge of the events. AFTER the club member has accumulated the required number of hours for the specific subsidy being requested, the member should complete the subsidy request form and turn it in. This form must be accompanied by the completed volunteer report form and copies of competition entry forms, showing entrance fees. If competition entry is done on line, print a copy of the confirmation of application/entry page and that may be attached to volunteer report forms.
3. Volunteer hour requirements (individual skaters):
 - \$25 for one USFS or ISI nonqualifying event.....4 hours
 - \$75 for three USFS or ISI nonqualifying event.....10 hours
 - \$135 for USFS Regionals, ISI Worlds or State Games of America (National Level).....15 hours
 - *****Additional \$300 for Jr. Nationals, Nationals or Adult Nationals.....+5 more hours
4. **Synchronized Skating teams** are also eligible for competition subsidies. Volunteer hours for the teams are accrued by team members or their parents serving in a volunteer capacity for the club. Team members should complete the volunteer report form being sure to include which team their hours should be credited towards. Once the team (as a whole) has completed the required number of hours, all paperwork should be collected by team coach/manager and turned in together (subsidy request form, volunteer report forms and copy of the competition entry form)
 - \$250 for nonqualifying sectionals.....20 hours
 - \$500 for qualifying sectionals.....40 hours
