## **Refund Policy**

Carolinas FSC has a **no refund policy**, with the following exceptions.

1. Injury – must have note from doctor or be obvious like a cast.
2. Illness – must have note from doctor.
3. Family emergency. What constitutes a family emergency is a death or serious illness in the family.

If you meet one of the above reasons for needing to cancel a test, after the deadline date, the club will either tear up your check or the club will write you a refund check, depending upon if the check has been cashed yet or not.

Note regarding contingent tests:

You will not receive a refund for scheduled tests that cannot be taken due to pre-requisite test receiving a RETRY result.

## **Test Session Space Priority Rules:**

The following is the order as to how received test applications are placed on the test agenda, in cases where testing ice time is limited.

### **First Priority:**

Home club members of Carolinas FSC based on postmark date.

Any applications that are postmarked after the deadline date will automatically not be considered if ice time is limited. (*This includes applications that have enclosed late fees.*)

If there are an exceeding amount of test applications than time will permit, and have been received on the same postmarked date, then scheduled test assignments will be placed according to the highest test level to be taken. *Highest test will have priority.*

### **Second Priority:**

Associate Members of Carolinas FSC.

Following space availability of home club members.

### **Third Priority:**

Non members of Carolinas FSC.

Following space availability of home club members, and associate club members.

Test sessions will not start prior to 5:00am without consulting the testers that it would affect. The testers that have been eliminated according to the above priority rules, will be given the option to test at the earlier hour (before 5:00am), if the test chair is able to accommodate them in the judges schedule.
